

1 MINUTES OF THE  
2 ENVIRONMENTAL QUALITY COMMISSION  
3 VILLAGE OF NORTHBROOK  
4 AUGUST 19, 2021

5  
6 Chairman Reynolds called the meeting to order at 7:00 p.m. in the Village Hall, Terrace  
7 Room. Present were Members Michael Beftink, Becky Lee, and Sandra Weiss

9 **Also Present:** Sustainability Coordinator Tessa Murray; Director of Development & Planning  
10 Services Michaela Kohlstedt

15 **Review and Approval of Minutes**

16 A motion to approve the minutes of the July 15, 2021 meeting with 2 corrections on P. 3,  
17 Line 10 and Line 16 should read "Member **Lee**" not Member Weiss. A spelling correction  
18 under Good and Welfare should read **Sue Schmittroth**. A motion was made by Member  
19 Weiss and seconded by Member Beftink. The motion was approved by unanimous voice  
20 vote.

22 **Hear From the Audience**

25 **Community Planning Report**

26 The Plan Commission unanimously recommended approval for promoting solar panels on  
27 rooftops including flat roofs. Director Kohlstedt will check the exact language that was  
28 approved by the Plan Commission and report back to the committee. The item will go to the  
29 full Board on September 14, 2021.  
30

31 Liaison Murray shared a map created by GIS staff that shows the location of every pollinator  
32 garden documented in incorporated Northbrook. It was discovered that The Trail Through  
33 Time is marked in the wrong location. Liaison Murray wants to discover if there is a  
34 potential wild life corridor that runs through the area. To have an approved pollinator  
35 garden one must have at least three milk weed plants and one other native plant that  
36 provides nectar for an adult monarch and a verbal commitment for low usage of pesticides.  
37

38 Member Weiss stated that ECQ should encourage schools to plant pollinator gardens.  
39 Liaison Murray will try to get the schools included.  
40

41 **Leafblower Update**

42 Chairman Reynolds referred to information in the packet where some communities are  
43 more punitive than others with regards to leaf blowers. He liked the idea of early spring and  
44 late fall exemptions for leaf blowers. He is comfortable with a ban on two-stroke engines  
45 with the exception of chain saws and snow blowers. Chairman Reynolds does not want to  
46 "pit neighbor against neighbor". He feels the issue will be complaint driven. Member Lee  
47

1 stated she does not feel that she is not in a comfortable position to make a  
2 recommendation and would like the Sustainability Commission to review. Membership had  
3 a discussion if leaf blower issues are decibel based or emission based issues. Member Weiss  
4 stated that leaf blowers are both decibel and emissions harmful. Member Beeftink suggests  
5 that two-stroke engines are the issue. Director Kohlstedt suggested that the Commission  
6 look at the matrix as a collective and see what other towns have recommended. Chairman  
7 Reynolds does not want to have an ordinance that is punitive with a fine. Director Kohlstedt  
8 stated that there could be an adjudication process. Member Lee would like to start with  
9 steps towards attainable goals. Member Lee is in favor of a small bite approach towards  
10 attainable goals. Chairman Reynolds favors a seasonal exemption with sunset clause and a  
11 ban on two-stroke leaf blowers and string cutters. The Commission would like more  
12 feedback from the Village Board and is concerned about enforcement. Member Lee would  
13 like to see landscapers register with the Village. Director Kohlstedt will have a discussion  
14 with Chief Kennedy and Jennifer Maisch on enforcement.  
15

16 **Green Steward Spotlight**

17 A Green Stewart draft website was included in the packet. Membership was given the  
18 opportunity to make comments. Comments were supportive. Director Kohlstedt stated it  
19 will shine a light on everyone doing wonderful things within the community.  
20

21 **Updates on Other Items:**

22 **a) Communication Initiatives & Messaging**

23 Liaison Murray stated that she will plan a post on the benefits of clover in a lawn.  
24

25 Liaison Murray announced the new electrical aggregation program. Residents will receive  
26 letters introducing the program. The Village newsletter will clarify the benefits. The Village  
27 approved a 36 month agreement with MC Squared Energy Services, LLC (mc2). Participation  
28 is optional. The savings collected will be used by the Village towards sustainability initiatives.  
29 Liaison Murray urged membership to share and pass out information on the plan.  
30 Northbrook is part of the North Shore Electricity Aggregation Consortium. Liaison Murray  
31 and Director Kohlstedt explained the differences between high energy and low energy users  
32 and how it related to the plan.  
33

34 Social Media posts include: 1) heat advisory reminding individuals to check on their  
35 neighbors; 2) tips on summer safety with regards to West Nile Virus; 3) Emergency Alert  
36 System Tests; 4) Paper recycling; 5) Somme Woods State Nature Reserve; 6) New recycling  
37 guidelines from Waste Management were shared with membership. Plastic types 1-5 are  
38 acceptable. Aerosol cans cannot be recycled; 7) UN Intergovernmental Panel on Climate  
39 Action Change calls for immediate political action for decarbonization.  
40

41 Member Lee stated that Red solo cups are not recyclable and to urge Flamingo Friday  
42 events to use cups that can be recycled.  
43

44 **b) Solar Permit Data**

45 June Solar Permit Data – No data to report.  
46

1 Pace Bus will not add any diesel fossil fuel powered buses to their fleet this year or in 2022.  
2 They are looking into electrifying their bus fleet.

3  
4 **c) Recycling & Waste Data**  
5 Our waste data has been updated by Waste Management  
6  
7 Membership is urged to apply for a seat on the Sustainability Commission. EQC will be more  
8 deeply tied to doing things through the lens of the CAP. The Sustainability Commission will  
9 have seven commissioners with a non-voting seat held by a local youth. The youth position  
10 must be applied for.
