Notes from Village President Sandy Frum...

Happy New Year!

On behalf of the Village Board of Trustees and Village Staff, I'd like to wish everyone a very Happy New Year! As we kick-off 2011, I am pleased to announce the Village will be launching a redesigned Village website later this month at www.northbrook.il.us

A new initiative we will be promoting this year is the "Drivers Must Stop for Pedestrians" program. This campaign is in response to legislation that was passed last year in Illinois House Bill 43. The measure requires drivers to come to a complete stop for pedestrians in all cross-walks – even those that are unmarked or don't have a stop sign or traffic light. Penalties vary by county. A first offense in Cook County includes \$150 minimum fine and \$160 for court costs. Violations in school zones are an additional \$50.

Before Illinois House Bill 43, the law required drivers to yield and stop only when necessary. That language led to confusion among drivers and pedestrians and made enforcement difficult. This updated law helps to ensure pedestrian safety. Illinois now joins dozens of states with similar laws, including California and Massachusetts. More than 6,000 pedestrians are hit by cars in Illinois each year, according to the Illinois Department of Transportation. These crashes result in more than 1,000 serious injuries and 170 fatalities annually.

This year I am asking for your support of a variety of "Village" events that residents enjoy annually, including 4th of July festivities, Northbrook Days and Shermerfest. While many consider these "Village" events, they are actually sponsored by local organizations and funded by community donations. Please consider supporting the organizations that coordinate these events, either by volunteering or contributing, so Northbrook can continue to enjoy these special annual traditions for years to come.

Good News from FEMA!

Following the annual recertification review, the Village has maintained a Class 7 Rating with the National Flood Insurance Program's Community Rating System (CRS). What does this mean for Village Residents? Residents who live in a Special Flood Hazard Area (SFHA) continue to qualify for a 15% reduction on flood insurance and those who do not live in a SFHA area can qualify for a 5% reduction.

How are residents notified? All residents and business owners with properties which are located within a Special Flood Hazard Area (SFHA) were notified by mail. In addition, this information is posted once a year in our September Village newsletter.

Quarterly Business Briefs...

Liquor Licenses for Charitable and Business Events

Northbrook's alcoholic beverage regulations (Chapter 4 of the Municipal Code) make it "unlawful to sell or offer for sale at retail or have upon any nonresidential premises for distribution to others any alcoholic beverage without having a village alcoholic beverage license." If a company or organization is holding an event on a nonresidential premise and wishes to serve liquor, the company holding an event is required to have the event catered by a catering company that holds a Village of Northbrook Class "G" Liquor License or temporary catering liquor license (Class "G-1"). The fee for a Class G-1 license is \$250.

There are two exceptions to this rule related to not-for-profit organizations and those events opened specifically to invited guests only. If your business is planning on having an event that includes serving alcoholic beverages, please contact Village Clerk Debbie Ford at dford@northbrook.il.us or at 847/509-5313. ☺

Downtown Parking

A frequent question the Village hears is "Can I park in the train station parking lots and shop at downtown businesses, or are the lots reserved for just commuters?" The answer is yes, you can park in the train station parking lots and shop at downtown businesses! The Village is in the process of making this more clear to residents and visitors with additional and more understandable public parking signs in the downtown.



To help guide motorists to downtown public parking lots, the Village will be installing directional signs throughout the downtown.



At the train station parking lots, signs at the entrances will more clearly identify them as parking lots open to the general public (commuters and shoppers alike) with free parking after 10:00am. Within the parking lots, there will be additional signs stating when you have to pay to park, as well as additional restrictions, including which rows are reserved for automobiles displaying a Northbrook vehicle sticker.

The Village trusts these signs will help commuters, shoppers and visitors more easily identify where they can park downtown. ☺

❖ News About Northbrook's Budget

Northbrook's 2010/11 Fiscal Year budget, May 2010-April 2011, projected a General Fund surplus for the year of \$29,767. When we reviewed the first quarter finances in August, we estimated the year-end surplus would be \$284,557. We are currently projecting the General Fund surplus to be \$400,704. The material differences are described below:

At the end of the first quarter, we estimated revenue to be over budget by \$114,000. Based on our most recent information, we currently estimate that revenues will be over budget by \$182,021. Positive trends in both sales taxes and building activity continue to provide signs of slow but sustained improvements in these revenue streams.

When we prepared the budget, we estimated that sales taxes would provide a modest 1% increase from last year. At the end of the first quarter, receipts were trending 6.8% ahead of budget. Since that was early in the fiscal year, we did not rely on sustaining that level of growth and only increased our projection for the year by 2.5%. Through the second quarter, sales tax receipts were 5.36% ahead of our budget expectation. With an additional three months of positive experience, we feel comfortable increasing the estimate by an additional ½% to a total of 3% for the fiscal year.

Building permit activity and revenue continue to show improvement. Through the first quarter, we had already realized 42% of our anticipated permit revenue for the fiscal year. While a large portion of this was attributable to the Nestle Pizza Division Headquarters project on Skokie Blvd., we had also seen a 17% increase in major permit applications from the same period last year. By the end of the second quarter, we had received permit revenue of \$464,226, which represents 66% of our budgeted revenue for the fiscal year. In November, we received an additional \$83,500. Based on this activity we have increased our estimate and anticipate year-end permit revenue to be \$150,000 more than budgeted.

At the end of the first quarter, we projected expenses would be \$140,790 below budget. We currently estimate that expenses will be \$313,507 under budget. The majority of the anticipated savings comes from vacant administrative positions, reduced usage of outside consultants and better than anticipated pricing on capital maintenance and replacement.

We remain confident that we will end the fiscal year above the original planned budget surplus in the Village's General Corporate Fund.

Through careful planning and judicious use of our resources, the Village has maintained sufficient reserves to weather this difficult economic climate without having to reduce services to the community or increase the tax burden to our residents and businesses. The Village Board will continue to pursue this goal as we develop the budget for next fiscal year.

❖ Board of Trustees Adopts New Comprehensive Plan for Village

The President and Board of Trustees formally adopted a New Comprehensive Plan for the Village during their December 14, 2010 meeting. The Comprehensive Plan will help guide land use, transportation and economic development decisions for the next ten to twenty years. The adoption of the Plan culminates over four years of work by the Village's Comprehensive Plan Advisory Committee (CPAC), Plan Commission, many of our volunteer Commissions and hundreds of Village residents and businesses who participated in the preparation of the document. Tips to Know When We Have Snow!

The next snowstorm might be just around the corner! Here are some important tips to make this winter a breeze!

Please Be Patient as the Public Works Department Clears Our Roadways!

Remember – It takes six to seven hours after the snow has stopped to clear Northbrook's roadways, and can take even longer during heavy or extended snowfalls. When driving, please give snow plows plenty of room. Large plows take longer to stop and have multiple blind spots.

Parking Restrictions When the Snow Falls

After a snowfall of two (2) or more inches, it is illegal to park on Northbrook streets until they have been completely cleared. Vehicles in violation are subject to ticketing and towing. If your vehicle has become disabled, call 847/564-2060 to inform the police.

Clear the Snow Around Your Nearest Fire Hydrant!

In case of an emergency, seconds count! Please assign someone in your household/neighborhood the responsibility of keeping fire hydrants on or near your property clear of snow for easy access.

Winter Snow Removal: Residents Encouraged to Pitch-in!

Please take the time to shovel the public sidewalks for the benefit of students, mail carriers and other pedestrians. It's courteous and the right thing to do... and contrary to rumors, there is no liability per state law! (745 ILCS 75/1 and 75/2 of the state statutes generally provides immunity to owners, lessors or occupants of residential property for shoveling snow.)

Northbrook Businesses Going Green!

Northbrook facilities of all types – from small businesses such as the North Shore Barrington Association of Realtors to large businesses such as Bell Flavors and Fragrances; condominium buildings such as the Northbrook Country Condominium Association to Retirement Communities such as Covenant Health Care, and even the Northbrook Historical Society – *are taking part in an innovative campaign to replace 1,000 incandescent exit signs with super-efficient LEDs.*

The Village of Northbrook's "Show Pollution the Door" campaign offers a simple opportunity for community members to save money, reduce energy consumption, lower their carbon footprint and enjoy brighter, safer exit signs.

By participating in the "Show Pollution the Door" program, businesses help create a greener Northbrook. So far, the campaign has reached nearly 20% of its 1,000-sign goal. Over the next ten years, the initiative will save Northbrook organizations and building owners more than \$997,000 in operating costs and keep almost five million pounds of carbon dioxide from entering the atmosphere.

The Historian's Corner

The Village marks another milestone in its history in 2011 when Northbrook celebrates its 110th birthday. History is not only about what happened many, many years ago, it is about what happened yesterday. Today's happenings are tomorrow's history!

Some things you may not know about Village streets:

- Eighteen of the streets in town are named for early settlers who helped shape the Village we call home today.
- E.D. Landwehr served on the state's Good Roads Committee planning to replace dirt roads with hard surface roadways. The Landwehr family name was given to one of the eighteen streets in town named for pioneer settlers.
- On Jan 17, 1975, the Historical Society was moved from the corner of Shermer and Waukegan Roads west on Shermer Road and across the Village Green Park to its present location at 1776 Walters Ave. Both Shermer and Walters were named after early settlers.
