Updates

Village Starts Work on New Fleet Maintenance Garage

This week, the Village marked the start of interior demolition for the new Fleet Maintenance Garage at 3504 Commercial Avenue, an adaptive reuse project that will transform an existing building into a modern, efficient facility supporting Public Works operations. The garage will serve as a 24/7 hub for maintaining more than 325 Village vehicles and equipment, including ambulances, fire apparatus, snowplows, and service trucks, with a range of maintenance bays, fabrication and welding areas, organized parts storage, and flexible workspaces. Designed to improve efficiency, reduce downtime, and enhance employee safety and wellness, the facility will also feature upgraded staff amenities and geothermal heating and cooling to support long-term sustainability.



On-Street Parking Ban Reminder

As a reminder, when snow accumulation is predicted to be greater than two inches during an upcoming event, an on-street parking ban may be implemented. The Village uses its Northbrook Notify system and social media to alert residents and businesses of emergency and non-emergency information, including parking bans related to snow events. 2026 Business License Renewal Process

The 2026 business license renewal process will begin in February. Invoices will be emailed to businesses in early February with a 45-day payment period. Businesses may submit payment through the [online payment portal](#), in person at Village Hall, or by mail via check. A reminder email will be sent 30 days after the initial notification. Businesses will be able to submit once for both their business license and outdoor dining permit applications.

Sewer Televising Update

The Village's contractor is currently televising 35,903 linear feet of sanitary sewer. While this work was originally anticipated to be completed by the end of January, extremely cold

temperatures last week delayed progress. The work is now estimated to be completed by Friday, February 6, weather permitting.
