Re: Cherry Lane Underpass Reconstruction – May 2023

Dear Resident:

The Village of Northbrook will be performing construction on Cherry Lane Underpass starting May 2023. The project was publically bid in January 2023 and approved by the Village Board of Trustees March 14th, 2023. The Contractor performing the work will be A Lamp Concrete Contractors, Inc. The planned improvements include the reconstruction of Cherry Lane between Cedar Lane and Meadow Road. The existing concrete pavement will be converted to asphalt pavement and deteriorated curb and gutter will be replaced.

What to Expect:

Construction Schedule

Work will begin May 1st, 2023 and starting May 8th, 2023, Cherry Lane Underpass will have the northern half shut down to facilitate Phase I of the project. During Phase I, one-way traffic will be maintained on the southern half of Cherry Lane, allowing eastbound traffic to pass through the work area. Once Phase I is completed, the southern half of Cherry Lane Underpass will be shut down to facilitate Phase II of the project. During Phase II, one-way traffic will be maintained on the northern half of Cherry Lane, allowing westbound traffic to pass through the work area. Complete reopening of Cherry Lane is anticipated to be no later than July 7th, 2023, and the final competition date is anticipated to be no later than July 14th, 2023.

Traffic Delays and Detours

Significant impacts to traffic are expected while the contractor is performing street reconstruction on Cherry Lane.

Parking Lot South of Cherry Lane Underpass

The parking lot on the South side of Cherry Lane Underpass will be closed to residents during the project to allow for the contractor to efficiently complete all required excavation, paving and pavement restriping work. Construction barricades and signage will be placed prior to the closure.

Construction Noise

The project work will generate noise and unfortunately the noise is unavoidable. Construction noise is not allowed before 7am on work days. Please contact the project manager if there are any concerns.

Stay Informed

The Village will be providing emailed project updates via NotifyMe. Instructions for how to sign up for NotifyMe email updates is enclosed. NotifyMe is the primary way Village staff will disseminate project information to the public. In addition to NotifyMe, project updates will be posted to the project web page which can be found on the Village's website at www.northbrook.il.us/CherryLane.




