BREEDER/HOBBYIST APPLICATION

APPLICANTS PLEASE NOTE:

The information requested in this application is that required pursuant to the provisions of Ordinance No. 78-49, Chapter 5 of the Village of Northbrook Municipal Code. Certain of those provisions are recited in this application for your reference. Generally:

"It shall be unlawful for any person to own, keep, care for, have custody of or knowingly permit at any time more than three (3) dogs or cats, in any combination thereof, to be upon any property in the Village, excluding properly licensed animal shelters; animal hospitals and clinics; grooming parlors; animal training schools and boarding kennels; the Village pound; and the premises of professional or hobbyist breeders granted a permit in accordance with Chapter 5, Article II, Section 5-39".

PART I GENERAL INFORMATION:

"No breeder permit shall be issued to any multiple family residential premises and only one (1) permit shall be issued to any one (1) household. The breeders permit shall be issued upon verification of the information provided; receipt of required certifications; satisfactory inspection of related premises and facilities by the Animal Control Officer; and payment of the fees involved". (Chapter 5 Article II Section 5-39c)

"It shall be unlawful for any person to own or harbor any dog or cat in the Village without having first obtained a license or appropriate permit therefore by application to the Village Manager...." (Chapter 5, Article II Section 5-36a)
