## Updates

### **Snow & Ice Response:**

- Public Works prepared for the anticipated snow and ice event that occurred on Wednesday, February 5 by pre-treating primary and secondary routes with organic liquid de-icing material to help prevent the bonding of snow to roadways and aid in the reduction of salt usage. Crews also inspected all truck snowplow and salting equipment, fueled vehicles, and loaded trucks with salt in advance. Beginning Wednesday evening, crews salted Village roadways and all Village-owned facilities, including the Metra commuter lots, and concluded the morning of Thursday, February 6.

### **New Customer Services:**

- Development and Planning Services staff has been conducting pre-permit application meetings with developers, property owners, architects, and various applicable Village staff to assist preparing applicants on what to submit when applying for permits for larger commercial projects. Both the customers and staff have found the meetings to be incredibly beneficial in preparing for projects inclusive of new technologies and/or product types.

### **Citizens Police Academy:**

- The Northbrook Police Department is currently accepting applications for the Citizens Police Academy that will take place Wednesdays from March 5th - April 30th from 7:00-9:30pm. The goal of the Citizens Police Academy is to strengthen the partnership between the Police Department and the community. Some of the core instruction topics include: emergency communications, patrol operations, criminal investigations, use of force training, crime scene processing, police canine techniques, and animal control.
