## INSTRUCTIONS

Please follow these instructions for completing the application form for your vehicle sticker and/or pet tag. If you have any questions regarding this form, please call (847) 272-5050.

1. All motor vehicles owned by a resident of the Village of Northbrook or by a person (applies to associations, clubs, societies, firms, partnerships, and bodies politic and corporate as well as to individuals) having its principal place of business in the Village shall be licensed on or before July 31 or within 45 days after the purchase of any motor vehicle or the establishment of residency or principal place of business within the Village.
2. Please verify the pre-printed information carefully and make the appropriate corrections where necessary. Information that is incorrect must be lined out and the correct information written below the pre-printed information. If you no longer have the vehicle or pet write **DELETE** in the same area. List all additional vehicles and/or pets you own or lease that are not pre-printed on the application by completing all of the requested information.
3. This application and payment will be returned if the required information is not furnished and/or the amount is incorrect.
4. A. Beginning June 2, vehicle stickers and pet tags may be purchased by mail, postage-free drop box, online at [northbrook.il.us/stickers](http://northbrook.il.us/stickers) or at the Village Hall with cash, check or credit card. Please submit both copies of the completed application to the Village Hall, 1225 Cedar Ln, Northbrook, IL 60062. First time pet tag applicants must apply in person or by mail with a rabies certificate and proof of spay or neuter.  
B. PLEASE DO NOT SEPARATE THE APPLICATION FORM. Submit a check or money order for the required amount payable to: Village of Northbrook. Do not mail cash. Do not include any other village payments in this envelope.

*\* The fee for motor vehicle stickers purchased within 45 calendar days of the purchase of the motor vehicle shall be the fee shown in the column marked "Fee Thru July 31" above. The fee for motor vehicle stickers purchased more than 45 calendar days after the purchase of the motor vehicle shall be shown in the column marked "Fee After July 31" above. However, the fee for motor vehicle stickers purchased on/or after January 1 of any licensing year shall be one-half of the otherwise applicable new vehicle fee.*

5. Please help alleviate hunger by making a special donation of \$20 or more to support the Hunger Resource Network, an all-volunteer 501(c)(3) organization.
6. Immediately upon receiving your vehicle sticker, affix it to the lower-left (driver's side) of the front windshield. Vehicle stickers must be displayed by August 1.
7. Please record the state license plate presently registered to the vehicle or indicate "applied for".
8. In order to purchase a pet tag, you must provide a valid certificate showing proof of rabies vaccination for each dog and/or cat to be licensed. Additionally, you **must** provide a valid veterinarian statement showing that the pet has been neutered/spayed in order to qualify for the lower pet tag fee. The rabies certificate and veterinarian statement will be returned to you with your pet tag(s). Pet tags should be affixed to the collar of your pet. First time pet tag applicants must apply in person or by mail with a rabies certificate and proof of spay or neuter.
9. **UNDER NO CIRCUMSTANCES** will vehicle stickers/pet tags be sold prior to June 2.
10. Please ensure that you enclose the correct fee amount – vehicle fees increase **after July 31**.
11. **UNDER NO CIRCUMSTANCES** will vehicle stickers and/or pet tags be sold out of sequential order.

## **SENIOR CITIZEN DISCOUNT**

The sticker for automobiles, motorcycles, and recreational vehicles owned by persons 65 and over shall be one-half of the applicable fee. A valid Illinois driver's license number must be provided in the applicable space on the application form. Vehicles with truck plates are excluded from the senior citizen discount.
